

<b>FACTS</b>		<b>WHAT DOES CU ALTERNATIVE LENDING SOLUTIONS, LLC (CUALS) DO WITH YOUR PERSONAL INFORMATION?</b>	
<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires lenders to tell you how they collect, share, and protect your personal information. Please read this notice carefully to understand what we do.		
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>• Social Security number and income</li> <li>• Account balances and payment history</li> <li>• Credit history and credit scores</li> </ul>		
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons CUALS, LLC chooses to share; and whether you can limit this sharing.

<b>What we do</b>			
<b>How does CUALS, LLC protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law.		

	<p>These measures include computer safeguards and secured files and buildings.</p> <p>All information collected is stored in a technically and physically secure environment. We store and transmit information with SSL encryption software.</p>
<b>How does CUALS, LLC collect my personal information?</b>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>● Apply for a loan</li> <li>● Give us your income information</li> <li>● Provide employment information</li> <li>● Provide account information</li> <li>● Give us your contact information</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
<b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>● Sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>● Affiliates from using your information to market to you</li> <li>● Sharing for nonaffiliates to market to you</li> </ul>
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	<p>Your choices will apply to everyone on your account.</p>

<b>Definitions</b>	
<b>Affiliates</b>	<p>Financial and nonfinancial companies related by common ownership or control.</p> <ul style="list-style-type: none"> <li>● <i>CUALS, LLC has no affiliates</i></li> </ul>
<b>Nonaffiliates</b>	<p>Financial and nonfinancial companies not related by common ownership or control.</p> <ul style="list-style-type: none"> <li>● <i>Nonaffiliates we share with can include service providers, direct mail, data processors and advertisers.</i></li> </ul>
<b>Joint Marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>● <i>Our joint marketing partners include financial institutions, credit card companies, partners that promote our products, pre-paid debit card providers and other lending companies.</i></li> </ul>
